- a) The School Managing Committee has not been constituted as per Affiliation Bye-laws, therefore, it may be reconstituted by including 02 representatives each of teachers, parents and CBSE. The school is required to forward a pager or 5-6 names of persons (at least 2 from KVS/JNV) not below the rank of Principal or 5r. Secondary School affiliated with the Board recommended so that two of them may be approved by the quart as its nominee in the School Managing Committee.
- b) The school is required to enhance the amount of reserve fund maintained in the joint names i.e. the Secretary, CBSE and the Manager of School and submit a copy of same to this office.

The school is required to furnish a copy of EPF Challan of Jatest month.

- d) The school is required to submit last year result of their candidates who were enrolled in classes X with the board.
- e) The school is required to ensure that pay-scales, DA and other admissible allowances are being paid to all the staff members at par with the corresponding categories of employees working in the State/Central Govt. Schools Also photocopy of acquaintance roll of latest month guly signed by all recipients and a certificate from the Bank to this effect are required to be submitted.
- f) There are few untrained teachers in the school whereas the school is required to appoint only trained and qualified teachers. Besides, the appointment of more trained and qualified teachers is also required to maintain section-teacher ratio as per norms. The school is also required to furnish a fresh staff statement accordingly.

g) The school is also required to furnish valid Sanitary Conditions, Drinking Water and Fire Safety Certificates issued by the competent authorities

More books are required to be purchased.
