3) JURISDICTION :

Jurisdiction of the Trust shall be throughout the country. However in initial stages it will be confined to Karnataka.

4) OBJECTS OF THE TRUST :

The objects of the Trust shall be -

To provide Education in General and Arts, Science, Commerce, Medical, Engineering and other fields including establishment of hospitals and Cultural Institutions in particular.

- (ii) To promote the welfare of the above categories of students and staff by establishing Hostels, and other assistance.
- (iii) To arrange lecturers Seminars, Symposia and conferences on General and Technical subjects.
- (iv) To conduct / Promote Research studies, Surveys on Technical subjects.
- (v) To conduct classes for Technical Students appearing for entrance examinations for GATE, GMAT, ECFMG etc.
- (vi) To do all that is relevant and incidental to the items (i) to (vi).

(5) LOCATION OF THE OFFICE OF THE TRUST :

The office of the trust shall be located for the time being at No. 4138, 2nd Main, 2nd Cross, Rajajinagar, Bangalore -21. The Board of Trustees shall have power to change the location of the place and office of the Trust to any other place other than Bangalore including Gulbarga.

(6) BOARD OF TRUSTEES :

- (i) The Board of Trustees shall consist of not less than 3 Trustees and not more than 15 Trustees.
- (ii) The Trustees named in this Deed of Trust as Trustees, shall be known as Founder Trustees.
- (iii) The Founder Trustees shall hold office as trustees for a period of 5 years from the date of this Deed of Trust, at the end of which period, as nearly as may be, one fifth of them shall retire by rotation in each successive year. ~~In the absence of agreement between them as to who should retire by rotation each year, the question shall be decided by drawing lots~~

- (iv) The trustees shall have the power to co-opt, from time to time, other trustees, provided the total number of Trustees shall not exceed 15.
- (v) Trustees so co-opted shall hold office for a period of 5 years from the respective dates of their becoming Trustees and shall thereafter retire.
- (vi) A retiring Trustee shall be eligible for being co-opted as trustee for further term 5 years unless he has incurred any disqualification.
- (vii) A trustee may resign from trusteeship by sending a letter of resignation under his signature addressed to the Chairman or the Managing Trustee of the Trust. Such resignation shall take effect from the date of its acceptance by the Board of Trustees.
- (viii) A Trustee shall cease to be Trustee if he is adjudged as Insolvent or declared as being of unsound mind by a competent court or if he is convicted and sentenced to imprisonment for an offence involving moral turpitude.
- (ix) A Trustee may be removed from Trusteeship if his continuance as Trustee is considered as being not in the interest of the Trust by not less than two thirds majority of the trustees present at the meeting of the Board of trustees in which a resolution to remove him a passed; provided no trustee shall be removed from Trusteeship unless he has been intimated in writing of the proposal to remove him and he has been given a reasonable opportunity to make a representation against his removal.
- (x) Any vacancy in the Board of Trustee due to retirement, death, resignation, disqualification removal or any other cause may be filled up by the remaining Trustees.

(7) OFFICE BEARERS OF THE TRUST :

- (i) All the office bearers of the of the Trust shall be elected by a majority of members present at the duly convened meeting of the Trust. The Trustees may, if they choose also elect among themselves a Vice-Chairman and an Honorary Secretary. In case of tie the incumbent Chairman/ Managing trustee shall have casting vote.
- (ii) The office bearers shall hold office for such term as may be decided by the Board of Trustees.
- (iii) Any office bearers shall hold office for such term as may be decided by the Board of Trustees.
- (iv) Any office bearers shall hold office for such may be removed at any time by the board of Trustees.

(8) MEETINGS :

- (i) The Board of trustees shall hold a meeting at least once in 3 months. It is open to Board to meet more often. There shall be 7 days notice for meeting of the Trust.
- (ii) One fourth the number of Trustees or three Trustees, whichever is less, shall form the quorum for a meeting of the Board of trustees.
- (iii) If the Chairman of the Board of Trustees is absent in any meeting of the Board, the Vice - Chairman, if any, shall preside at such meeting. In the absence of both the Chairman and the Vice Chairman, the Trustees present at the meeting shall elect one amongst them as the Chairman for that meeting.

- (iv) Resolutions and all others matters before the Board of trustees shall be regarded as being passed or decided if it is supported by a majority of the Trustees present at the meeting. In case of tie Chariman / Managing trustee shall have casting vote.
- (v) Meeting of the trustees shall be held at the shorter notice.
- (vi) Meeting of the Trustees shall be held at the Head quarters of the Trust or any other place decided by the Chairman / Managing Trustee.
- (vii) The following categories of resolutions shall not be regarded as being passed unless at least two thirds of the number of Trustees present at the meeting vote in favour of the resolution.
- i) A resolution to remove a Trustee from trusteeship.
 - ii) A resolution to borrow money fro the Trust with or without security.
 - iii) A resolution to sell, mortgage or otherwise transfer any immovable property of the Trust.
 - iv) A resolution amend the terms of the Deed of trust.
 - v) A resolution to dissolve the Trust and to hand over the assets of the Trust to any other Trust, Society or Institution.

(9) **FUNDS OF THE TRUST :**

- (a) The funds of the trust shall consist of -
- i) The amount settled by the Settlor under this deed;
 - ii) Donations and contributions received by the Trust ;
 - iii) Grants received from the Governments or any Organisation or Institutions.
 - iv) Amounts repaid by grantees of loan scholarships; and
 - v) Income from any properties of the Trust.
 - vi) Fees and other sources.

- (b) The funds of the Trust shall be kept in a Bank or Banks and operated jointly by the Treasurer along with the Chairman or the Managing Trustee.

ACCOUNTS :

- (a) The Trustees shall maintain or cause to be maintained proper accounts of all receipts and payments relating to the Trust and shall get such accounts audited once in a year by a Chartered Accounting. The audited Statement of accounts together with the Report of the Auditor shall be placed before the Board of Trustees at its meeting.
- (b) The accounting year of the trust shall be from the 1st day of April to the 31st day of March of the following calender year.

INVESTMENT :

The funds of the Trust shall be invested in Bank Deposits or in Fixed Deposits in Government Companies or in other Government Financial Institutions and the Trustees shall have power to vary much investment from time to time;

Provided that no investment shall be made except in accordance with the provisions of Section 13 (1) (d) read with Section 1 (5) of the Income Tax Act, 1961.

POWER OF THE BOARD OF TRUSTEES :

- (a) The Board of Trustees shall have all lawful powers necessary or convenient for carrying out the objects of the Trust and for management of the properties of the Trust.
- (b) Without prejudice to the generality of such powers, the Trustees shall have power -

- ii) To remove any such person and to the disciplinary action against any such.
- iii) To acquire, hold and manage for the Trust both movable and immovable properties.
- iv) To sell, mortgage and otherwise transfer movable and immovable properties of the Trust ;
- v) To make contributions to any activity in the public field keeping in mind the objects of the Trust.

- vi) To receive donations, gifts, contributions and grants;
- vii) To borrow monies with or without security.

Provided that the decisions to borrow money shall be by a resolution of the Board of trustees passed by a majority of not less than two thirds the number of Trustees present at the meeting of the Board in which such resolution is passed;

- viii) To open accounts in Banks and to operate such accounts;
- ix) To enter into contracts on behalf of the Trust ;
- x) To maintain and defend suits and other legal proceedings in courts and Tribunals and to engage Advocates therein for safeguarding the interest of the Trust and its properties.

It shall be the duty of the Chairman / Managing Trustee to get the Minutes of the meeting of the Trust recorded and maintain them accordingly.

- xii) It shall be the duty of the other office bearers and Trustees to assist and carry out the works entrusted by the Chairman / Managing Trustee.

- xiii) Powers of the trustees shall be exercised by the Chairman / Managing Trustee for ensuring the proper and smooth functions of the Trust, pending ratification by the Board of Trustee.

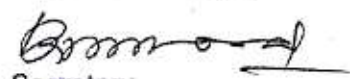

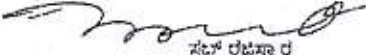

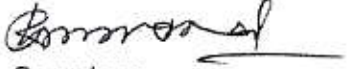
